





Fresh Corn Salad

Easy summer side dish!!



Ingredients:

For the salad:

- 4 ears fresh corn
- 15 ounces can black beans, rinsed and drained
- 8 ounces cherry tomatoes, halved
- ½ cup chopped red onion
- ½ cup cilantro, chopped
- 3 ounces Cotija cheese, crumbled*
- 1 large avocado, chopped

For the dressing:

- ¼ cup lime juice, about 4 limes
- ¼ cup olive oil
- ¾ teaspoon chili powder
- ½ teaspoon cumin
- ½ teaspoon garlic powder
- ½ teaspoon kosher salt
- 1/8 teaspoon pepper


Instructions

- Heat grill to medium heat. Remove husks and silks from corn, rinse and pat dry. Rub oil lightly on the cobs. Grill directly on the grates for 12 – 15 minutes, turning every 3-4 minutes, until you have nice grill marks on all sides.
- While the corn cools, make the dressing. Whisk together all dressing ingredients in a small bowl. Set aside.
- Once the corn is cool, carefully use a sharp knife to slice the kernels off the cob. Place corn kernels in a large bowl.
- Add the black beans, tomatoes, red onion, and cilantro. Pour the dressing over the salad and toss gently to combine. Stir in the Cotija cheese. If serving the salad within 2 hours, you can stir in the avocado now. Otherwise, wait and add the avocado right before serving. Salad is best if chilled for at least 2 hours before serving.
